#### Why do we issue this Information Notification

The extension of max. TX current allows a higher flexibility of the antenna design and matching network, an improvement of the RF performance is possible. This improvement gives the opportunity to drive larger antennas in difficult antenna environments like proximity of metal, presence of display screens and especially for terminals which have to comply with EMVCo RF requirements.
