End-of-life announcement for Solarlok PV4 connector

Description of Changes
Dear Customer, As you may be aware starting on 11DEC2017 the existing PV connector norm EN 50521:2008+A1 will expire. At that time, all PV connectors will be required to meet the IEC 62852 norm. All of the norm changes will result in TE obtaining new TUV certification numbers for our products. As the successor has better performance and same mating interface with PV4 connector, we've made the decision to obsolete the parts stated thereafter. As said, alternative products with improved specifications and performance are available and meet the new IEC 62852 norm, called PV4-S.
